Motion by Miller, seconded by Johnson to increase the valuation of Parcel #R18.112.0090 to \$1,000,000. Motion by Keers, seconded by Tinklenberg to amend the motion to increase the valuation of Parcel #R18.112.0090 to \$1,200,000. Yeas: Keers, Remund, Tinklenberg. Nays: Johnson, Miller, Steinhoff. Motion failed. Motion by Keers, seconded by Miller to amend the motion to increase the valuation of Parcel #R18.112.0090 to \$1,100,000. Yeas: Keers, Miller, Remund, Tinklenberg. Nays: Johnson, Steinhoff. Motion carried. Chairman Remund called for a vote on the motion to increase the valuation of Parcel #R18.112.0090 to \$1,100,000. Yeas: Keers, Miller, Remund, Tinklenberg. Nays: Johnson, Steinhoff. Motion carried.

Motion by Miller, seconded by Tinklenberg to increase the valuation of Parcel #R17.500.0760 to \$400,000. Motion carried unanimously.
