FOR THE 2020 GENERAL ELECTION
PIPESTONE COUNTY, MINNESOTA**

Notice is hereby given as provided in Minnesota Statutes 204B.33, that a general election will be held on Tuesday, November 3, 2020, for the purpose of electing candidates for the offices listed below. The filing period for these offices begins at 8:00 AM Tuesday May 19, 2020 and ends at 5:00 PM, Tuesday, June 2, 2020. Candidates may file in person or by mail if the filing is received during the filing period. Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes Section 204B.09, subdivision 1a may arrange to file during the seven days immediately preceding the candidates' absence from the state. Be aware that the Legislature and/or the Governor may take actions that could affect some of the processes due to the COVID-19 situation.
